

22. DISTRIBUTIVNA TRGOVINA

METODOLOŠKA OBJAŠNJENJA

Izvori i metode prikupljanja podataka

Izvori podataka o distributivnoj trgovini jesu redovita istraživanja: Tromjesečni izvještaj distributivne trgovine za pravne osobe (TRG-2), Tromjesečni izvještaj distributivne trgovine za obrtnike (TRG-2/OBRT) i Godišnji izvještaj distributivne trgovine (TRG-3) te istraživanje Izvještaj o prodajnim kapacitetima u trgovini na malo (TRG-41).

Tromjesečni izvještaj distributivne trgovine za pravne osobe (obrazac TRG-2) provodi se izvještajnom metodom i njime su obuhvaćene pravne osobe koje se bave nekom od djelatnosti iz područja G NKD-a 2002. Trgovina na veliko i na malo; popravak motornih vozila i motocikla te predmeta za osobnu uporabu i kućanstvo.

Tromjesečni izvještaj distributivne trgovine za obrtnike (obrazac TRG-2/OBRT) provodi se izvještajnom metodom, a njime su obuhvaćene fizičke osobe (obrtnici) koje su prema pretežnoj djelatnosti registrirane u području G NKD-a 2002.

Godišnjim izvještajem distributivne trgovine (TRG-3) prikupljaju se finansijski podaci o poslovanju pravnih osoba koje obavljaju djelatnosti distributivne trgovine. Provodi se izvještajnom metodom na bazi uzorka.

Izvještaj o prodajnim kapacitetima na malo (TRG-41) iscrpno je istraživanje kojim su prikupljeni detaljni podaci o veličini i strukturi maloprodajne mreže u Hrvatskoj za 2004. Istraživanjem su obuhvaćeni svi poslovni subjekti koji obavljaju trgovinu na malo. Snimaju se sva prodajna mjesta: prodavaonice i prodajna mjesta izvan prodavaonica. Podaci iz tog istraživanja iskazani su u tablicama 22-17. do 22-19. i 44-3.

Obuhvat i usporedivost

U području statistike unutrašnje trgovine početkom 1998. provedena je cijelovita revizija svih statističkih istraživanja radi njihove prilagodbe međunarodnim standardima i postizanja bolje kakovće podataka (ponajprije radi boljeg obuhvata izvještajnih jedinica).

Tako se od 1998. pod unutrašnjom trgovinom obuhvaćaju sve djelatnosti iz područja G NKD-a 2002., a to su djelatnosti trgovine na veliko i na malo, posredovanja u trgovini na veliko te popravaka motornih vozila i motocikla i predmeta za osobnu uporabu i kućanstvo, za razliku od prijašnjih godina, kad su bile obuhvaćene samo trgovina na malo i trgovina na veliko. Djelatnosti iz područja C NKD-a 2002. jedinici imenom zovu se Distributivna trgovina. Pod trgovinom na veliko, u smislu distributivne trgovine, obuhvaća se i izvoz i uvoz, ali se izvoz i uvoz promatraju zasebno i podrobnije se objavljuju u posebnom poglavju ovog Ljetopisa Ekonomski odnosi s inozemstvom. Ovo poglavje sadrži podrobne podatke o distributivnoj trgovini na domaćem tržištu, a podaci o izvozu ovdje se promatraju samo usputno, kao dio aktivnosti trgovine na veliko obuhvaćenih poslovnih subjekata i nije nam cilj obuhvatiti ga u cijelosti.

Istraživanja distributivne trgovine za pravne osobe od 1998. temelje se na metodi uzorka, gdje se kao okvir za izbor uzorka koriste prošireni adresari sastavljeni od triju administrativnih registara: Registra poslovnih subjekata i dijelova poslovnih subjekata koji se vodi u Državnom zavodu za statistiku, Registra Financijske agencije i Registra Porezne uprave Ministarstva finacija. Time je postignut bolji obuhvat izvještajnih jedinica, za razliku od prijašnjih godina, kad je zbog neažurnosti registara i slabe statističke discipline izvještajnih jedinica obuhvat bio vrlo loš. Na osnovi rezultata dobivenih uzorkom ocjenjuje se cijeli skup. Uzorkom su obuhvaćeni svi veliki i srednji te mali poslovni subjekti izabrani metodom slučajnog uzorka koji su prema pretežnoj djelatnosti razvrstani u područje G NKD-a 2002. Također su obuhvaćeni i poslovni subjekti koji su prema pretežnoj djelatnosti razvrstani u druge djelatnosti, ali imaju registrirane dijelove koji obavljaju trgovinske djelatnosti. Pri ocjeni skupa nisu uzeti u obzir poslovni subjekti koji su registrirani u ostalim djelatnostima i obavljaju trgovinsku djelatnost, ali nemaju registrirane dijelove u trgovinskim djelatnostima. Stratifikacija uzorka rađena je na osnovi pretežne djelatnosti i veličine poslovnog subjekta.

Pri iskazivanju podataka primijenjeno je sljedeće načelo: poslovni subjekti čija je glavna djelatnost trgovina (neka od djelatnosti iz područja G NKD-a 2002.) iskazuju podatke za sve svoje djelatnosti koje obavljaju, pa i za one koje nisu trgovske. Poslovni subjekti čija je glavna djelatnost izvan trgovine (npr. proizvodnja, promet i sl.) iskazuju podatke samo za trgovske djelatnosti koje obavljaju.

Od 1998. promijenjen je i način praćenja izvještajnih jedinica, tako da je uvedeno posebno istraživanje za praćenje pravnih osoba, a posebno za praćenje obrtnika.

Istraživanje unutrašnje trgovine za fizičke osobe (obrtnike) od 1998. također

NOTES ON METHODOLOGY

Sources and methods of data collection

Data on distributive trade are obtained through regular statistical surveys: the Quarterly Report on Distributive Trade of Legal Entities (TRG-2 form), the Quarterly Report of Tradesmen (TRG-2/OBRT form), the Annual Report on Distributive Trade (TRG-3 form and the Report on Selling Capacities in Retail Trade (TRG-41).

The Quarterly Report on Distributive Trade of Legal entities (TRG-2 form) is carried out by using a sampling method and includes legal entities engaged in any activity defined in section G of the NKD 2002.: Retail and wholesale trade; Repair of motor vehicles and motorcycles and personal and household goods.

The Quarterly Report on Distributive Trade of Tradesmen (TRG-2/OBRT form) is carried out by using a sampling method and includes natural persons (tradesmen) defined by their prevailing activity in section G of the NKD 2002.

The Annual Report on Distributive Trade (TRG-3 form) is used in collecting financial data on the operation of legal entities engaged in the distributive trade activity. It is carried out by using the reporting method based on a sample.

The Report on Selling Capacities in Retail Trade (TRG-41) is a detailed survey collecting data on size and structure of the retail trade network in Croatia in 2004. The survey covers all business entities engaged in retail trade. All sales outlets have been monitored: stores and other sales outlets (non-store sale). The data have been presented in tables 22-17 to 22-19 and 44-3.

Coverage and comparability

At the beginning of 1998, in the field of domestic trade, all statistical researches were entirely revised in order to be harmonised with international standards as well as to achieve higher data quality (in the first place of better coverage of reporting units).

Therefore, starting with 1998, domestic trade comprises all activities defined in section G of the NKD 2002. as follows: Retail and wholesale trade, Mediation in wholesale trade and Repair of motor vehicles and motorcycles and personal and household goods. In the previous years only retail and wholesale trade were comprised. Activities as defined in section G of the NKD 2002. are united into distributive trade. Wholesale trade in the sense of distributive trade also comprises export and import, but they are viewed separately and published in detail in this Yearbook in the chapter Economic Relations with Foreign Countries. This chapter contains detailed data on distributive trade on domestic market, while exports data are viewed only incidentally, as a part of wholesale activities of business entities covered in survey and it is not our purpose to cover it entirely.

Since 1998, distributive trade survey for legal entities has been based on the sampling method where expanded address lists served as a frame for choosing a sample. These lists consist of three administrative registers: the Register of Business Entities and Parts Thereof, which is kept by the Central Bureau of Statistics, the register of the Financial Agency and the register of the Tax Administration Office of the Ministry of Finance. In that way, reporting units are better covered, as compared to previous years when the coverage was very poor because registers were not updated and the statistical discipline was very loose. The estimate of the whole group is based on results obtained by sampling method. The sample includes all large, medium-size and small business entities chosen on the basis of a random sample, classified by prevailing activity in section G of the NKD 2002.. Business entities classified by prevailing activity into other sections are also included if their parts are registered in trade activities. When the whole group is estimated, business entities registered in other sections and engaged in trade activities are excluded if their parts are not registered in trade activities. The stratification of a sample is done on the basis of prevailing activity and size of business entity.

The following principle was used in presentation of data: business entities having trade as their main activity (any activity defined in section G of the NKD 2002.) provide data on all activities they are engaged in, even non trading ones. Enterprises/trade companies, with their main activity being outside trade (e.g. manufacture, transport and the like) present their data only for trade activities they are engaged in.

Since 1998, the way of monitoring reporting units has been changed by introducing special surveys, one for monitoring legal entities, and the other one for monitoring tradesmen.

Since 1998, the survey on domestic trade for natural persons (tradesmen) has

se provodi izvještajnom metodom na osnovi uzorka. Okvir za uzorak jest datoteka obveznika poreza na dohodak Porezne uprave odnosno sloganovi svih obrtnika koji su u toj datoteci registrirani u području G NKD-a 2002. Stratifikacija uzorka rađena je prema pretežnoj registriranoj djelatnosti obrta. Ovdje je korišteno načelo da obrtnici iskazuju samo ukupan podatak za sve svoje djelatnosti koje obavljaju. Pri ocjeni cijelog skupa nisu uzeti u obzir obrtnici koji obavljaju trgovinske djelatnosti, ali u njima nisu registrirani.

Zbog svega navedenoga nije moguće osigurati višegodišnje serije podataka s detaljnim podacima za godine prije 1998. Serija podataka iskazana je samo u tablicama 22-1. i 22-2. U tablici 22-1. prikazani su samo indeksi za zbirne podatke za djelatnosti trgovine na malo i trgovine na veliko, gdje su indeksi od 1998. nadalje dobiveni novim, revidiranim istraživanjem, a indeksi za prijašnje godine dobiveni su iz istraživanja koja su u tim godinama provođena.

Podaci po županijama dobiveni su također tromjesečnim istraživanjima na bazi uzorka. Budući da stratifikacija uzorka nije rađena po županijama, ti podaci nemaju predviđeni stupanj točnosti. Kvaliteta dobivenih rezultata ovisi i o stupnju obuhvata izvještajnih jedinica na razini županija. Podaci po županijama za pravne osobe obrađeni su prema organizacijskom načelu, a podaci za obrtnike prema sjedištu vlasnika obrta.

U pojedinim tablicama može se dogoditi da ukupno ne odgovara zbroju pojedinih stavki zbog zaokruživanja iznosa dobivenih postupkom procjene iz uzorka na cijele brojeve.

Definicije

Distributivna trgovina jest skup svih oblika trgovачkih aktivnosti, od nabave robe od proizvođača do isporuke te robe krajnjem potrošaču. Ona obuhvaća trgovinu na veliko za svoj račun, posredovanje u trgovini na veliko, trgovinu na malo i popravke motornih vozila i motocikla te predmeta za osobnu uporabu i kućanstvo.

Trgovina na veliko (skupine 51.2 – 51.9, podrazredi 50.10.1, 50.30.1 i 50.40.1 NKD-a 2002.) djelatnost je kupnje i preprodaje robe industrijskim, trgovackim i profesionalnim korisnicima i ustanovama te drugim poslovnim subjektima koji se bave trgovinom na veliko ili na malo. Tu je uključen transzitni promet robe (prodaja robe koja se po nalogu prodavača neposredno isporučuje kupcu iz skladišta ili drugog odredišta proizvođača, uvoznika ili drugoga poslovnog subjekta bez prethodnog uskladištenja te robe kod prodavača).

Posredovanje u trgovini na veliko (skupina 51.1, podrazredi 50.10.3, 50.30.3 i 50.40.3 NKD-a 2002.) obavljanje je djelatnosti trgovine na veliko uz naplatu ili prema ugovoru. Tu su uključene prodaja s konsignacijskim skladišta, djelatnosti komisionara (opunomoćenika, agenata), posrednika za trgovacku robu i svih drugih veletrgovaca koji trguju uime ili za račun drugih te djelatnosti onih koji su uključeni u povezivanje prodavača s kupcima ili poduzimaju trgovacke transakcije uime vlasnika robe. Ne obuhvaćaju se robne burze.

Trgovina na malo (skupine 52.1 – 52.6, podrazredi 50.10.2, 50.30.2, 50.40.2 i razred 50.50 NKD-a 2002.) prodaja je robe krajnjim potrošačima, tj. stanovništvu za osobnu uporabu ili uporabu u kućanstvu.

Popravci motornih vozila i motocikla te predmeta za osobnu uporabu i kućanstvo (razred 50.20, podrazred 50.40.4, i skupina 52.7 NKD-a 2002.) obuhvaćaju djelatnosti onih popravaka predmeta za osobnu uporabu i kućanstvo koji nisu povezani s prerađivačkom djelatnosti, trgovinom na veliko ili trgovinom na malo.

Prodavaonica je prodajna prostorija u kojoj se obavlja trgovina na malo. U redovitim istraživanjima obuhvaćaju se klasične prodavaonice, samoposluzivanja, robne kuće, zakupljeni prodajni prostor unutar robnih kuća, kioski i benzinske postaje.

Broj zaposlenih uključuje sve osobe koje stvarno rade u poslovnom subjektu, a to su: svi zaposleni; vlasnici, suvlasnici i neplaćeni članovi obitelji koji redovito rade u poslovnom subjektu; osobe koje rade izvan prostorija matičnog poduzeća (npr. trgovacki predstavnici, dostavljaci, ekipa za popravku i održavanje); osobe odsutne na kraće vrijeme (npr. zbog bolesti, porodnog dopusta, plaćenog dopusta); osobe u štrajku; radnici koji rade skraćeno radno vrijeme; radnici koji obavljaju posao kod kuće; sezonski radnici i vježbenici. Isključuju se radnici odsutni na neodređeno vrijeme, osobe koje također rade u promatranoj poslovnom subjektu, ali ih je tamo poslao neki drugi poslovni subjekt (npr. osobe koje obavljaju popravke u promatranome poslovnom subjektu za račun drugog poduzeća); osobe na odsluženju obveznoga vojnog roka. Izvještajne jedinice vrlo često odstupaju od ove definicije jer iskazuju samo plaćene radnike u poslovnom subjektu.

Prosječan godišnji broj zaposlenih u tablici 22-3. dobiven je kao prosjek broja zaposlenih na kraju svakog tromjesečja.

also been carried out through reports based on the sampling method, where the database of tax payers from the Tax Administration Office, that is, all the magnetic data of tradesmen recorded in that database in section G of the NKD 2002., serves as a sampling frame. The sample stratification was done according to the registered prevailing activity of craft/free lance. The principle used here is that tradesmen represent the total of all the activities they are engaged in. While the whole group is estimated, tradesmen engaged in trade activities are excluded if they are not registered in those activities.

Therefore, it is not possible to ensure continuous data series with detailed information for the years before 1998. The data series are represented only in the tables 22-1. and 22-2. The table 22-1. shows only indices for collective data on retail and wholesale trade, where indices for years beginning with 1998 and further on are calculated by using a new revised survey, while indices for earlier years are calculated by using the data obtained through surveys that were done in those years.

Data by counties were also obtained quarterly by sampling method. As the sample stratification has not been done at the county level, these data lack the expected grade of accuracy. The quality of the given results depends on the coverage of the reporting units at the county level. Data by counties on legal entities were worked out according to the principle of organisation, and data on tradesmen according to the headquarters of the owner of craft/free lance.

In certain tables it may happen that the total does not equal the sums of individual figures, for sums obtained by the method of estimation from samples were rounded to whole numbers.

Definitions

Distributive trade is a set of all types of trade activities, from supplying goods from the producer to distributing them to the final consumer. It comprises wholesale trade on one's own account, wholesale on a fee or contract basis, retail trade and repair of motor vehicles and motorcycles and personal and household goods.

Wholesale trade (groups 51.2 – 51.9, subclasses 50.10.1, 50.30.1 and 50.40.1 of the NKD 2002.) is an activity of sale of goods to industrial, trading and professional users and organisations as well as to other business entities engaged in wholesale or retail trade. It also includes transit goods trade (sales of goods which is by a vendor's order directly delivered to a customer from a warehouse or any other place put in by a producer, importer or other business entity, without being previously stored at the salesman's).

Wholesale on a fee or contract basis (group 51.1, subclasses 50.10.3, 50.30.3 and 50.40.3 of the NKD 2002.) consists of performing of wholesale trade by payment or contract. It includes sales from consignment warehouses, commissioners' services (representatives, agents), mediator for trading goods and other wholesale vendors operating in the name or on the account of others, as well as an activity of those who are engaged in connecting vendors with customers or undertake trade transactions on behalf of the owner of goods. Stock exchange is not included.

Retail trade (groups 52.1 – 52.6, subclasses 50.10.2, 50.30.2, 50.40.2 and class 50.50 of the NKD 2002.) is the sale of goods to final consumers for personal consumption or use in households.

Repair of motor vehicles and motorcycles and of personal and household goods (group 52.7, class 50.20 and subclass 50.40.4 of the NKD 2002.) comprises activities or repairs of personal and household goods not connected to manufacture, wholesale or retail trade.

Sales outlets are business premises where retail trade is conducted. Regular surveys cover: shops, self-service stores, department stores, rented sales space within department stores, kiosks and petrol stations.

Number of employed persons includes all persons actually working in a business entity: all persons in paid employment, owners, co-owners and unpaid family members who regularly work in a business entity; persons working outside central premises of an enterprise (e.g. sales representatives, messengers, repair and maintenance teams); persons on short leaves (e.g. for sickness, maternity leave, paid vacation); persons on strike; short time workers; persons who are working at home; seasonal workers and trainees. It excludes persons who are absent for an indefinite time period, then persons working in a monitored business entity, but sent by another business entity (e.g. persons performing repairs in a monitored business entity on account of another enterprise); persons included in obligatory military service. Reporting units often do not stick to this definition because they show only persons in paid employment in a business entity.

The average annual number of persons in employment in the table 22-3. has been calculated from the average number of persons in employment at the end

Promet je vrijednost svih prodanih roba i usluga na tržištu bez obzira na to jesu li naplaćene, s uključenim porezom na dodanu vrijednost. Iznimka su podaci o prometu dobiveni iz Godišnjeg izvještaja distributivne trgovine – TRG-3, gdje porez na dodanu vrijednost nije uključen.

Zalihe se iskazuju sa stanjem na kraju godine, i to prema knjigovodstvenoj vrijednosti. Zalihe robe koje se nalaze u skladištima iskazuju se kao zalihe u trgovini na veliko, a zalihe robe u prodavaonicama kao zalihe u trgovini na malo.

Trgovačke stuke predstavljaju stvarni pretežni assortiman prodaje u trgovini na malo, gdje su skupine proizvoda koji se pretežno prodaju razvrstane također na osnovi Nacionalne klasifikacije djelatnosti (NKD 2002.).

Turnover is a value of sold goods and services on the market irrespective of the fact whether they are paid or not, with VAT included. Exceptions are data on turnover obtained through the Annual Report on Distributive Trade – TRG-3, where VAT is not included.

Stocks are presented in the state at the end of the year, based on bookkeeping. Stocks in warehouses are shown as stocks in the wholesale trade, while stocks in outlets are shown as stocks in the retail trade.

Branch is the actual prevailing assortment of sale in retail trade, in which groups of prevailingly sold products are also classified according to the NKD 2002.




