

## 20. TRANSPORT I KOMUNIKACIJE

### METODOLOŠKA OBJAŠNJENJA

#### Izvori i metode prikupljanja podataka

Podaci o prijevozu, pratećim i pomoćnim djelatnostima u prijevozu te poštanskim, kurirskim i telekomunikacijskim uslugama prikupljeni su izvještajnom metodom, tjednim, mjesecnim, tromjesečnim ili godišnjim statističkim izvještajima. Podaci su prikazani prema NKD-u 2002., područje I, i odnose se na željeznički prijevoz, ostali kopneni prijevoz (cestovni), pomorski i obalni prijevoz, prijevoz unutrašnjim vodenim putovima, zračni prijevoz i cjevovodni transport. Prikazani su podaci o pratećim i pomoćnim djelatnostima u prijevozu (prekrcaj, rad morskih luka, rad luka unutrašnjim vodenim putovima i rad zračnih luka) te poštanske, kurirske i telekomunikacijske usluge. Podaci o duljini i vrsti cesta prikupljeni su od Hrvatskih cesta d. o. o. Podaci o broju registriranih cestovnih motornih i priključnih vozila, vozača i prometnih nesreća prikupljeni su od Ministarstva unutarnjih poslova Republike Hrvatske.

#### Obuhvat i usporedivost

Podaci o željezničkoj infrastrukturi, prijevoznim sredstvima te prijevozu putnika i robe odnose se na rad pravnih osoba koje su upisane u Registrar poslovnih subjekata u Državnom zavodu za statistiku, a obavljaju željeznički prijevoz putnika i robe. Podaci o željezničkom prijevozu putnika obuhvaćaju i gradski prijevoz putnika.

Podaci o cestovnom prijevozu putnika odnose se na rad poslovnih subjekata koji se bave prijevozom putnika autobusima.

Od 2001. podaci o cestovnom prijevozu robe odnose se na rad poslovnih subjekata koji raspolažu cestovnim teretnim vozilima registriranim kod Ministarstva unutarnjih poslova i bave se prijevozom robe u javnom prijevozu ili za vlastite potrebe.

Istraživanje se provodi metodom uzorka, tjednim praćenjem rada uzorkom izabranih vozila.

Statističke jedinice jesu cestovna teretna motorna vozila (uključujući tegljače) nosivosti veće od 3 500 kg, registrirana kod Ministarstva unutarnjih poslova. Izvještajne jedinice jesu poslovni subjekti (pravne i fizičke osobe) koji su vlasnici ili korisnici cestovnoga teretnoga motornog vozila izabrana uzorkom.

Podaci o gradskom prijevozu odnose se na rad poslovnih subjekata koji obavljaju gradski prijevoz (tramvajima i autobusima) u gradskim i prigradskim naseljima.

Podaci o cestovnom graničnom prometu motornih vozila obuhvaćaju sva cestovna motorna vozila, putnike i robu koji su prešli granicu i ušli u Republiku Hrvatsku odnosno izašli iz Republike Hrvatske. Uključena su vozila i putnici u tranzitu.

Podaci o cestovnom graničnom prometu osobnih vozila, autobusa i putnika te podaci o graničnom prometu putnika u željezničkom, pomorskem i zračnom prijevozu prikupljeni su iz evidencije granične policije Ministarstva unutarnjih poslova. Izvor podataka za cestovni granični promet teretnih motornih vozila i robe jest evidencija Carinske uprave.

Podaci o cjevovodnom transportu odnose se na rad pravnih osoba koje su upisane u Registrar poslovnih subjekata u Državnom zavodu za statistiku. Cjevovodni transport obuhvaća transport nafte i transport plina.

Podaci o pomorskom i obalnom prijevozu odnose se na rad poslovnih subjekata koji se bave pomorskim prijevozom. Istraživanjem su obuhvaćene sve pravne osobe koje raspolažu teretnim brodovima tonaže veće od 1 000 GT odnosno putničkim brodovima tonaže veće od 600 GT.

Podaci o prijevozu robe na unutrašnjim vodenim putovima odnose se na rad

### TRANSPORT AND COMMUNICATION

#### NOTES ON METHODOLOGY

##### Sources and methods of data collection

Data on transport, supporting and auxiliary activities in transport and postal, courier and telecommunication services are for the most part obtained from monthly, quarterly and annual statistical reports. Data are presented according to the NKD 2002., section I and relate to: railway transport, other land transport (road), sea water and coastal transport, inland water transport, air transport and transport via pipelines. Data are presented on supporting and auxiliary activities in transport (cargo transhipment, activity in seaports, activity in ports of inland water transport, activity at airports) and postal, courier and telecommunication services. Data on the length and type of roads have been taken over from the Croatian Roads. Data on registered motor vehicles and trailers, drivers and road accidents are supplied by the Ministry of the Interior of the Republic of Croatia.

##### Coverage and comparability

Data on railway infrastructure, transport equipment, transport of passengers and goods refer to the activity of legal entities registered in the Register of Business Entities of the Central Bureau of Statistics that are engaged in railway transport of passengers and goods. Also included is the urban transport of passengers.

Data on road transport of passengers relate to activity of business entities that are engaged in transport of passengers by buses.

Since 2001, data on road transport of goods have related to activity of business entities engaged in transport of goods for hire or reward or for own account that dispose of road goods vehicles, which are registered with the Ministry of the Interior.

The random sample method is used to carry out the survey. Vehicles selected into the sample are monitored during the period of one week.

Statistical units are goods road motor vehicles (including road tractors) with a loading capacity of over 3 500 kg, which are registered with the Ministry of the Interior. Reporting units are business entities (legal entities and natural persons) owning or just using a goods road motor vehicle selected into the sample.

Data on transport in urban areas include the activity of business entities engaged in providing transport (by tramways and buses) in urban and suburban areas.

Data on road cross-border traffic of motor vehicles cover all road motor vehicles, passengers and goods entering and leaving the territory of the Republic of Croatia, including vehicles and passengers in transit.

Data on cross-border road traffic of passenger cars, buses and passengers, as well as data on cross-border traffic of passengers in railways, sea water and air transport are collected from records of the border police of the Ministry of the Interior. Data source for cross-border traffic of freight motor vehicles and goods are the records of the Customs Administration Office.

Data on pipeline transport relate to the activities of legal entities registered in the Register of Business Entities of the Central Bureau of Statistics. Pipeline transport includes transport of oil and gas.

Data on seawater and coastal transport relate to the activities of business entities which are engaged in seawater transport. Including all legal entities that dispose of cargo ships of over 1 000 GT and passenger ships of over 600 GT.

Data on inland water transport relate to the operation of business entities which are engaged in inland water transport.

poslovnih subjekata koji se bave prijevozom robe unutrašnjim vodenim putovima.

Podaci o zračnom prijevozu odnose se na rad pravnih osoba koje su upisane u Registar poslovnih subjekata u Državnom zavodu za statistiku, a bave se zračnim prijevozom putnika i robe. Podaci se prate od 1991.

Podaci o pratećim djelatnostima prekrcajnih usluga odnose se na rad pravnih osoba koje su upisane u Registar poslovnih subjekata Državnog zavoda za statistiku, a bave se prekrcajem u morskim lukama, lukama unutrašnjih voda (pristaništa), na željezničkim kolodvorima i ostalim mjestima.

Podaci koji se odnose na promet u morskim lukama obuhvaćaju prispjele i otputovalje putnike te prispjelu i otpremljenu robu brodovima domaćih i stranih zastava te se odnose na rad svih morskih luka u Republici Hrvatskoj. Obuhvaćeni su svi brodovi čija je duljina veća od 12 m i bruto tonaža veća od 15 ili su ovlašteni prevoziti više od 12 putnika. Od 2004. primjenjuje se nova metodologija te je znatno poboljšan obuhvat unutrašnjeg prometa i podaci nisu usporedivi s prijašnjim godinama.

Podaci o prometu brodova, putnika i robe po lučkim kapetanijama i lukama odnose se na statističke luke. Pri definiranju statističke luke kao polazna osnova uzet je već postojeći definirani sustav lučkih ispostava. Podatak za svaku statističku luku sadržava i podatke za sve izvještajne luke koje su u djelokrugu dotočne statističke luke. Podaci o prometu putnika uključuju i putnike na brodovima za kružna putovanja (tzv. cruiser).

Podaci o pratećim djelatnostima na unutrašnjim vodenim putovima odnose se na rad luka unutrašnjih vodenih putova, a obuhvaćaju robu prispjelu i otpremljenu brodovima domaćih i stranih zastava. Podatke dostavljaju kapetanje luka unutrašnjih vodenih putova. Kako bi se postigla međunarodna usporedivost podataka u području prijevoza unutrašnjim vodenim putovima i prometa u lukama na unutrašnjim vodenim putovima u 2005. je promijenjen obuhvat istraživanja pa je došlo do prekida vremenske serije. Podaci nisu usporedivi s prijašnjim godinama.

Podaci o pratećim djelatnostima u zračnom prijevozu obuhvaćaju rad zračnih luka: prihvrat zrakoplova, putnika i robe. Obuhvaćeni su domaći i strani zrakoplovi.

Podatke o poštanskim i kurirskim uslugama dostavljaju pravne osobe koje su upisane u Registar poslovnih subjekata Državnog zavoda za statistiku, a bave se poštanskim i kurirskim uslugama. Pismenosne i paketne pošiljke obuhvaćaju broj pismenosnih pošiljaka prispjelih u unutrašnjem prometu te prispjelih i otpremljenih u međunarodnom prometu.

Podaci o telekomunikacijskim uslugama odnose se na rad pravnih osoba koje su upisane u Registar poslovnih subjekata Državnog zavoda za statistiku, a bave se telekomunikacijskim uslugama.

Podaci o broju ozlijeđenih i poginulih osoba u prometnim nesrećama, dobiveni od MUP-a, obuhvaćaju sve sudionike prometnih nesreća na teritoriju Republike Hrvatske bez obzira na državljanstvo. Osobom poginulom u prometnoj nesreći smatra se svaka osoba smrtno stradala na mjestu nesreće i umrla do 30 dana od posljedica nesreće na teritoriju Republike Hrvatske, bez obzira na državljanstvo.

## Definicije

**Prijevoz uz naknadu ili nagradu** u cestovnom prijevozu (javni prijevoz) jest prijevoz ljudi i robe koji se obavlja uz naknadu u ime trećih osoba.

**Prijevoz za vlastite potrebe** u cestovnom prijevozu jest prijevoz koji se ne obavlja uz naknadu ili nagradu.

**Putnik** je svaka osoba koja putuje u cestovnom, željezničkom, vodenom ili zračnom prijevoznom sredstvu isključujući uslužno osoblje vlaka, autobusa,

*Data on air transport relate to the operation of legal entities registered in the Register of Business Entities of the Central Bureau of Statistics, which are engaged in air transport of goods and passengers. They have been monitored since 1991.*

*Data on supporting and auxiliary transhipment activities relate to the operation of legal entities registered in the Register of Business Entities of the Central Bureau of Statistics, which are engaged in transhipment in sea ports, inland waterway ports (landing places), railway stations and other places.*

*Data on traffic in seaports include arrivals and departures of passengers and on loaded and unloaded goods on ships under domestic and foreign flags and relate to activities in all seaports in the Republic of Croatia. This covers all ships with length of more than 12 m and of over 15 gross tonnage or those authorised to carry more than 12 passengers. Since 2004, a new methodology has been applied, so data are not comparable to previous years and the statistical coverage of domestic traffic has been significantly improved.*

*Data on traffic of ships, passengers and goods according to harbour master's offices refer to statistical ports. An already existing „port system“ of branch offices of harbour master's offices has been used as the initial base on defining „statistical ports“. The data on each statistical port include also the data of all ports under competence of statistical port concerned. Data on traffic of passengers include passengers on cruise ships.*

*Data on supporting and auxiliary activities in inland water transport relate to the operation of inland water ports that include arrivals and departures of goods on both domestic and foreign vessels. The data are supplied by harbour master's offices. In order to obtain the international comparability of data the coverage of survey has been changed in the area of goods transport in inland waterways and inland waterway ports in 2005 leading to the break in time series. Data are not comparable with previous years.*

*Data on supporting and auxiliary activities in air transport relate to the operation of airports: receipt of aircrafts, passengers and goods. Included are both foreign and domestic aircrafts.*

*Data on postal and courier services are supplied by legal entities registered in the Register of Business Entities of the Central Bureau of Statistics, which are engaged in postal and courier services. Letter and parcel postal services include the number of letters arrived in domestic traffic, as well as those arrived and sent in international traffic.*

*Data on communication services relate to activities of legal entities registered in the Register of Business Entities of the Central Bureau of Statistics, which are engaged in communication services.*

*Data on killed and injured persons in traffic accidents, submitted by the Ministry of the Interior, comprise all participants of traffic accidents on the territory of the Republic of Croatia, irrespective of their citizenship. A person killed in a traffic accident is any person killed on the spot or died on the territory of the Republic of Croatia within 30 days from effects of a traffic accident, irrespective of citizenship.*

## Definitions

**Transport for hire or reward** in road transport is the carriage for remuneration, of persons or goods, on behalf of third parties.

**Transport on own account** in road transport is a transport that is not for hire or reward.

**Passenger** is any person who makes a voyage on road, rail, seawater and air transport equipment, excluding service staff.

Prijevoz putnika (s obzirom na prijelaz državne granice) dijeli se na unutrašnji i međunarodni.

**Unutrašnji prijevoz** obuhvaća prijevoz putnika obavljen između mjesta ukrcaja i mesta iskrcanja unutar granica Republike Hrvatske.

**Međunarodni prijevoz** obuhvaća prijevoz putnika između mjesta ukrcaja u Republici Hrvatskoj i mesta iskrcanja u inozemstvu i obratno te prijevoz obavljen između dva mesta u inozemstvu.

Pod **robom** se podrazumijeva svaka roba koja se prevozi željezničkim, cestovnim, vodenim, zračnim prijevoznim sredstvima i transportira cjevovodima.

Prijevoz robe dijeli se na sljedeće kategorije:

**Unutrašnji prijevoz** podrazumijeva prijevoz robe obavljen između ukrcajnih i iskrcajnih mesta unutar granica Republike Hrvatske.

**Izvoz** podrazumijeva prijevoz robe koja je ukrcana unutar granica Republike Hrvatske, a iskrcana u nekoj stranoj zemlji bez obzira na podrijetlo robe.

**Uvoz** podrazumijeva prijevoz robe koja je ukrcana izvan granica Republike Hrvatske, a iskrcana u Republici Hrvatskoj bez obzira na podrijetlo robe.

**Tranzit bez prekrcanja (izravni)** podrazumijeva prijevoz robe kroz hrvatski teritorij istom vrstom prijevoza između dva mesta (mjesta ukrcaja i mesta iskrcanja) koja se nalaze u drugoj zemlji ili drugim zemljama.

**Tranzit s prekrcajem** podrazumijeva prijevoz robe kroz hrvatski teritorij između dva mesta koja se nalaze u drugoj zemlji ili drugim zemljama s prekrcajem robe u Hrvatskoj.

**Putnički kilometar** jest mjerna jedinica koja izražava prijevoz jednog putnika na udaljenosti od jednoga kilometra.

**Tonski kilometar** jest mjerna jedinica koja izražava prijevoz jedne tone robe na udaljenosti od jednoga kilometra.

### Željeznički prijevoz

**Gradičinska duljina pruge** jest duljina željezničke pruge mjerena po osi kolosijeka (pruge) od početne do završne točke građenja.

**Inventurni park prijevoznih sredstava** obuhvaća sva vlastita željeznička vozila koja dijelimo prema osnovnoj namjeni na ona koja se kreću svojom vlastitom snagom ili koja vuče drugo prijevozno sredstvo. Željeznička vozila koja se kreću vlastitom snagom obuhvaćaju lokomotive svih vrsta. Prijevozna sredstva podijeljena su prema namjeni na ona za prijevoz putnika i ona za prijevoz robe.

**Lokomotivski (vozni) kilometri** prijedeni su kilometri lokomotiva.

**Vučeni brutotoniski kilometar** jest mjerna jedinica koja izražava kretanje na udaljenosti od jednoga kilometra jedne tone vozila i sadržaja isključujući masu vučnog vozila. Uključena je masa motornih kola.

### Cestovni prijevoz

**Državna cesta** jest javna cesta koja povezuje cjelokupni teritorij Republike Hrvatske s mrežom europskih cesta, a ima najmanje dva prometna traka širine najmanje tri metra.

**Županijska cesta** jest javna cesta koja povezuje područje jedne ili više županija.

**Lokalna cesta** jest javna cesta koja povezuje područje grada i/ili općine.

*If considered in terms of country borders, transport of passengers is divided into domestic and international one.*

*Domestic transport is conveying of passengers between the place of embarkment and the place of disembarkment within the borders of the country.*

*International transport is conveying of passengers between the place of embarkment in our country and the place of disembarkment abroad, or the other way round, as well as between two places in another country.*

*Goods are any goods moved on rail, road, sea and on navigable inland waterway, air transport equipment and via pipeline.*

*Transport of goods is divided into the following categories:*

*Domestic transport implies transport of goods between places of loading and unloading within the borders of the country.*

*Export implies transport of goods loaded in our country and unloaded in another country, irrespective of the origin of goods.*

*Import implies transport of goods loaded out of our country and unloaded in our country, irrespective of the origin of goods.*

*Transit without transhipment (direct transit) implies transport of goods through Croatian territory in the same means of transport between two places (a place of loading and a place of unloading), both located in another country or in other countries.*

*Transit with transhipment implies transport of goods through Croatian territory between two places, both located in another country or in other countries with transhipment of goods in Croatia.*

*Passenger kilometre is a unit of measure representing transport of one person over a distance of one kilometre.*

*Tonne kilometre is a unit of measure representing transport of one tonne over a distance of one kilometre.*

### Railway transport

*The construction length of line is a distance measured between the beginning point to the final point of construction.*

*Rolling stock includes own railway vehicles that are basically divided according to their purpose, to those moving under their own power or hauled by other vehicles. Railway vehicles moving under their power comprise all types of locomotives. Transportation means are divided into the ones for carrying passengers and the ones for carrying goods.*

*Locomotive (train) kilometres are distances in kilometres travelled by locomotives.*

*Gross tonne-kilometre hauled is a unit of measure representing the movement over a distance of one kilometre of one tonne of vehicle and contents, excluding the weight of tractive vehicle. The weight of railcars is included.*

### Road transport

*State road is a public road that connects the whole territory of the Republic of Croatia with the European roads network, consisting of at least two lanes not less than 3 m wide.*

*County road is a public road that connects the territory of one or more counties.*

**Autocesta** je javna cesta posebno sagrađena i namijenjena isključivo prometu motornih vozila koja ima dva fizički odvojena kolnička traka (zeleni pojasa, zaštitnu ogragu i sl.) za promet iz suprotnih smjerova s po najmanje dva prometna traka širine najmanje 3,5 m, bez raskrižja s poprečnim cestama i željezničkim ili tramvajskim prugama u istoj razini, u čiji se promet može uključiti odnosno isključiti samo određenim i posebno sagrađenim priključnim prometnim trakovima za ubrzavanje ili usporavanje odnosno priključnim rampama, kojom je omogućen siguran prometni tok vozila brzinom od najmanje 80 km/h i koja je kao autocesta označena propisanim prometnim znakom.

**Međunarodna E-cesta** javna je cesta međunarodnim aktom svrstana u mrežu međunarodnih cesta.

**Vozilo na motorni pogon** svako je vozilo koje se pokreće snagom vlastitog motora, osim vozila koja se kreću tračnicama. Vrste vozila na motorni pogon: moped, motocikl, osobni automobil, autobus, teretni automobil, kombinirani automobil, radni stroj, radno vozilo i traktor.

#### Granični promet

**Granični prijelaz** jest mjesto namijenjeno prijelazu državne granice.

**Granični prijelazi za međunarodni promet** namijenjeni su graničnom prometu građana Republike Hrvatske i građana drugih zemalja.

**Granični prijelazi za međudržavni promet** namijenjeni su graničnom prometu građana Republike Hrvatske i građana susjednih zemalja.

#### Pomorski prijevoz

**Luke** su posebno sagrađena mjesta na morskoj obali u kojima se ukrcavaju i iskrcavaju putnici i teret.

**Brod** je plovni objekt namijenjen za plovidbu morem čija je duljina veća od 12 m i bruto tonaža veća od 15 ili je ovlašten prevoziti više od 12 putnika.

**Putničkim brodovima** smatraju se svi brodovi koji imaju više od 12 putničkih mjesta.

**Teretnim brodovima** smatraju se brodovi namijenjeni ponajprije prijevozu tereta, a nemaju više od 12 putničkih mjesta.

Kapacitet brodova iskazuje se u sljedećim jedinicama:

**GT** (bruto tonaža) jest mjerna jedinica koja iskazuje zapremninu ukupnoga zatvorenog prostora broda.

**kW** jest mjerna jedinica za optimalnu snagu brodskih motora.

**DWT** je nosivost broda, odnosno dopuštena težina tereta koji se može istodobno smjestiti na brod.

**Putnička milja** jest mjerna jedinica koja izražava prijevoz jednog putnika na udaljenosti od jedne morske milje.

**Tonska milja** jest mjerna jedinica koja izražava prijevoz jedne tone robe na udaljenosti od jedne morske milje. Tonske milje preračunavaju se u tonske kilometre prema omjeru 1 milja = 1 852 metra.

#### Zračni prijevoz

**Bruto nosivost** jest razlika ukupne težine zrakoplova pri polijetanju i bazne težine zrakoplova.

**Neto nosivost** ili raspoloživa korisna nosivost zrakoplova plaćeni je kapacitet zrakoplova predviđen za prijevoz putnika, prtljage, robe i pošte. Broj radnih letova odnosi se na komercijalne redovite i izvanredne letove.

**Prijevoz tereta** obuhvaća prijevoz robe i pošte u domaćem i međunarodnom prijevozu.

**Local road** is a public road that connects the territories of a town (city) and/or municipality.

**Motorway** is a public road specially built and intended for the traffic of motor vehicles, having two non-adjoining carriage ways for traffic (green area, protective fence, etc.) in either direction with at least two lanes not less than 3.5 m wide, no crossing with roads, railways or tramways on the same level and with specially constructed lanes for speeding or slowing down and junctions for access or exit which make traffic safer and easier at speed of at least 80 km/h; the motorway is marked with a prescribed traffic sign.

**International E-road** is a public road included in the international road network under international agreements.

**Motor vehicle** is a vehicle that drives by using its own means of propulsion, except for the vehicles on rails. Types of motor vehicles: moped, motorcycle, passenger car, bus, goods road vehicle, light van, work engine, work vehicle, road tractor.

#### Border traffic

**Border crossing** is a place intended for crossing the state border.

**Border crossings for international traffic** are intended for cross-border traffic of citizens of Republic of Croatia and citizens of other countries.

**Border crossings for interstate traffic** are intended for cross-border traffic of citizens of Republic of Croatia and citizens of the neighbouring countries.

#### Seawater transport

**Ports** are places especially built on a seaside for loading and unloading goods and passengers.

**Ship** is seagoing vessel designed for navigation at sea with length more than 12 m and more than 15 GT or authorised for transport more than 12 passengers.

**Passenger vessels** are all vessels with 12 passenger seats and over.

**Cargo ships** are ships for the carriage of cargo and have up to 12 passenger seats.

**Carrying capacity of ships** is expressed in the following units:

**GT (gross tonnage)** is unit of measure expressing a total closed space below and above ship deck.

**kW** is a unit of measure for optimum power of ship engines.

**DWT** represents a maximum load of a ship, that is, total weight allowed.

**Passenger mile** is a unit of measure representing a transport of one passenger over a distance of one sea mile.

**Tonne-mile** is a unit of measure representing a transport of one tonne of goods over a distance of one sea mile. Tonne miles are converted into tonne-kilometres by the ratio 1 mile = 1 852 meters.

#### Air transport

**Gross carrying capacity** is a difference between its maximum permitted weight at take-off and its basic weight.

**Net carrying capacity or available useful capacity** is a paid capacity of an aircraft intended for transport of passengers, luggage, cargo and posts. Number of working flights refers to commercial regular and special flights.

**Freight transport** includes goods and mail transport in the domestic and international transport.

**Roba** izražava težinu prevezene robe osim pošte, zaliha i prtljage uključujući ekspresne i diplomatske torbe, ali ne i prtljagu putnika.

**Pošta** izražava pismovne pošiljke i druge predmete prevezene zrakoplovom koji su dostavljeni od ili su namijenjeni za dostavu poštanskoj administraciji.

#### Telekomunikacije






**G 20-1. PREVEZENI PUTNICI OD 1997. DO 2006.**  
PASSENGERS CARRIED, 1997 – 2006




**G 20-2. PRIJEVOZ ROBE U 2005. I 2006.**

INTERNATIONAL GOODS TRAFFIC IN SEA PORTS, 1997 - 2006




**G 20-4. REGISTRIRANA CESTOVNA VOZILA OD 1997. DO 2006.**
